1) 1254 Industries, LLC (1254) or its manufacturers will not assume responsibility if you do not verify your written request with this quoted bill of materials.

2) Sales Tax is not included on this quote. It is your responsibility to advise 1254 if your required to pay sales tax at time of the order. A new quote will be issued with added sales tax. If you are exempt from paying sales tax then a Resale Certificate will need to be provided at time of order.

3) This quotation is subject to manufacturer's terms and conditions.

4) This quotation is made without benefit of complete plans and specifications. It is your responsibility to ensure this quote

accurately represents your bill of material. If a substitution is quoted, 1254 will not guarantee approval unless stated on the quote. The quote is based on part numbers.

5) Any changes will require a new quote. If the complete quote is not used then a new quote will be needed.

6) Source inspections or out of state inspection charges are not included unless specifically notated on the quote. These charges are the responsibility of other.

7) Cal-Trans projects will require design year, luminaire mast arm length, signal mast arm length, tenon locations, etc., etc., prior to order. Orders cannot be released without this information. 8.3 requirements are not included unless stated on this quote.

8) Lamps, photocells, fuses, spare parts, or special product requirements are not included unless stated on quote.

9) Anchor bolts released prior to order is subject to freight charges and will be added to invoice.

10) Acceptance of order is contingent upon credit approval.

11) The responsibility of setting up any and all inspections with cities requiring inspections is up to the electrical or general contractor and is not the responsibility of 1254 & manufacturer. If the contractor would like 1254 to help assist is arranging these inspections, 1254 will need a written letter authorizing us to do so. Any and all costs above any allowance given in a quote are the responsibility of the contractor.

12) Freight allowed quotes include two hours of offloading time. Additional charges of \$200/hour will apply if delivery offloading time exceeds the maximum two hour limit.

PAYMENT TERMS:

1) Payment by the customer is due and payable within your account terms upon receipt of your invoice. If payment is not received within said terms notated on your invoice, customer will be assessed a late charge equal to 1.5% of the unpaid amount per month.

ORDER CANCELLATIONS:

1) Orders are subject to cancellation fees. If you intent to cancel your order, it is your responsibility to notify us promptly of cancellation. Cancellation fees will vary based on costs incurred during production of your order and the date of notification.

RESTOCKING & RETURN POLICY:

This policy is for all products manufactured by 1254 Industries, LLC. You will have 30 days from delivery date to request a return. All return requests will need to be reviewed and approved before items can be shipped back to 1254. Restocking fees will be assessed upon the nature of the buyers order and items will be returned at the buyers expense. Custom orders may or may not be elgible for return. Any credits issued will be applied to the customer's account only; unless otherwise agreed upon. The credit amount will be maintained and applied to future products/services and will be reflected on the customer's next invoice.
